

CROSS RIVER COMBO CLUB TEAM TRY-OUTS

- Try-outs will be held for the assembly of Cross River Combo's U16 and U19 teams. The try-out fee is \$35.00. The U16 team will be comprised of mostly rising freshmen, (graduating 2021) with an exception made for highly skilled rising 8th graders that their coach believes they are above their grade level. While the U19 team will be comprised mostly of rising sophomores and juniors (graduating classes 2020 & 2019) with the exception of younger players that are skilled enough to make the team as a freshman. 2018 graduates are welcome to try-out for the team but will only be practice players and will not participate in the traveling tournament. Results of try-outs will be released by email 1-2 days after the try-out.

What it means to join Cross River Combo

- Both the U16 and U19 teams will train during the late spring, summer, and in the fall. We will be having 12-14 practices throughout those seasons, most of them being in the summer (2-3 spring, 2-3 fall). Practices will be held either at Dietz Stadium in Kingston or at SUNY New Paltz, based on availability of the facilities. Players can expect to have a training fee between \$200-\$225 for these practices.
- Selection for the U19 team means the player will travel to the Winter Escape tournament held in Naples, FL during the first weekend in January. Last year's cost of this tournament was roughly \$750.00 per player. That included air fare, hotel, tournament fee, van transportation and other incidental costs. **Alternates for the U19 team will practice with the team and may be asked to travel in the event that a selected team player has to drop out.
- There will be an attendance policy. Once the practice schedule is set, U19 selected players are allowed one missed practice, alternates are allowed two practices. U16 team players will also have a two missed practice policy.
