- All teams must check in ½ hour before first game
- NO CLEATS allowed; turf shoes or sneakers only
- As always, this tournament is non-contact

Game Format

- 27 minute running time games
- (4) indoor rubber-infill turf fields. Each field 30 x 60 yards
- Boys - 7 players on the field (2 attack, 2 defense, 2 middies & goalie)
- Girls - 7 players on the field (2 attack, 2 defense, 2 middies & goalie)
- No more than 2 long poles on field at anytime (Boys)
- One 1-minute timeout per game - clock does not stop
- All substitutions on the fly
- One face off per game
- Controlled clear (on referees whistle) after each goal is scored
- Penalty: all penalties will result in a structured fast break from mid-field, Offending player will come off the field. Attack/Defense at GLE
- Player with 4 personal Fouls in a game (Cross checks, Slash, Unsportsmanlike play) will be removed
- Game time will be centralized for all four games. Single horn will start and stop play at the beginning and end of each game. No time-outs may be taken inside of the last two minutes of either half.
- Unless modified by preceding statements, we will follow standard rules as stated in 2021 US Lacrosse Rules book
- Championship determined by CHAMPIONSHIP GAME or POINTS

1. I ACKNOWLEDGE, agree, and represent that I understand the nature of such activities and that I am of the opinion that said minor is qualified, in good health, and in proper physical condition to participate in such activity. I further agree and warrant that if at any time I believe that such minor's health and physical condition should change so that it would be unsafe for such minor to continue to participate in such activity, I will immediately discontinue the minor's future or further participation in such activity.

2. I FULLY UNDERSTAND THAT: (a) such minor's participation in the aforesaid activities involve risk and danger of serious bodily injury, including permanent disability, paralysis, and death ("risks"); (b) these risks and dangers may be caused by said minor's actions or inactions, the actions or inactions of others participating in the activity, the condition in which the activity takes place, or the negligence of Hudson Valley Sportsdome, Inc. and Hudson Valley Domicile, LLC; (c) there may be other risks including potential exposure to communicable disease (including but not limited to coronavirus/COVID-19 and all other infectious pathogens and disease vectors) and social economic losses either known or not known to me or not readily foreseeable at this time, and I fully accept and assume all such risks and responsibilities for losses, costs and damages such minor may incur as a result of the minor's participation in the activity.

I UNDERSTAND that it is my responsibility to assure compliance by the Minor of all posted and published procedures, including safety and hygiene procedures and protocols intended to lessen the likelihood of the spread of disease among participants and staff. In my absence, I authorize the RELEASEES and medical care provider(s) to carry out any emergency medical transport or medical care for the minor, as may be necessary in their sole discretion, and agree to be fully responsible for any costs associated with such transport and care.
